EDUCATIONAL NOTIFICATION

In connection to the Spot Round NEUT counselling, 2021, the Directorate of Higher Education, Tripura has been decided to conduct the counselling as per their approved business rules, available in the Brochure at CSAB Portal under CSAB NEUT section on 17th December, 2021 at the Ground Floor of the Shiksha Bhawan, Office Lane, Agartala, Tripura (W), PIN: 799001.

In this connection, the following guideline is being issued for allotment of the vacant Supernumerary seats in Engineering/Architecture after the online NEUT counselling, with the following modalities:-

Eligibility for appearing in the Spot Round Counselling

1) The aspiring candidates will have to follow the instructions as provided at the www.csab.nic.in website; and, allotment will be done as per the Business Rules uploaded by the CSAB 2021. The conversions (de-reservation) of seats from one category to another (if required) will be done as per Business Rules after the two iteration of allotment in spot round.

2) The spot round is an offline process and no online registration is required by the candidates. They have to report to the venue as per the schedule given below along with all necessary documents (original and self-attested photocopy) mentioned in the NEUT Business Rule 2021 and with recent Passport size colour photograph.

3) All eligible candidates, whether they registered or not (i.e. new candidates) for CSAB NEUT 1st round, whether any seat allotted or not from 1st/2nd Round, whether reported online or not, can participate in the spot round (although it is not mandatory for students who have been allotted a seat in round 1 or 2 to participate in spot round).

4) Candidates who have a confirmed seat allotment under CSAB NEUT 2021, with admission letter issued to them from 1st/2nd Rounds, cannot participate in Spot Round unless they 'Withdraw' their currently allotted seat. Withdrawal must be done within the 13th to 15th December 2021, through the CSAB Portal under NEUT section.

Once the currently allotted seat is withdrawn / surrendered, the claim of the candidate on the withdrawn seat will be lost, irrespective of whether a seat is subsequently allotted in the Spot round or not.

5) Candidates having valid JEE (Main) 2021 rank, will become eligible for allotment of seat.

Required arrangement to conduct NEUT Spot Round Counselling 2021

6) (i) 'Registration Form for NEUT Spot Round counselling' will be available in the website of Directorate of Higher Education (www.highereducation.tripura.gov.in) from 13/12/2021.

(ii) For eligible candidates with JEE (Main)-2021 score card, who did not register themselves in the CSAB NEUT Counselling process, shall have to send email with the scanned copy of the filled up 'Registration Form for NEUT Spot Round counselling' to the Email Id: neutspotround.tr@gmail.com within 15/12/2021 (up to 12:00 PM). After this date and time, no application from such candidate will be considered.

(iii) Candidates who are already registered in the CSAB NEUT 2021 Counselling Portal will bring and submit filled up 'Registration Form' at the time of Spot Round of NEUT counselling.

7) (i) On the day of counselling, candidate has to reach the venue (the Ground Floor of the Shiksha Bhawan, Office Lane, Agartala, Tripura (W), PIN: 799001) of the spot round counselling within 10:30 AM along with documents as mentioned in Para-2 above.


(ii) Once a seat has been allotted, the claim of the candidate on that seat will be lost, in case the candidate stayed absent/ temporarily absent during the Spot round counselling.

(iii) All candidates who register for the spot round counselling and get a seat (fresh allotment) will be required to pay an allotment fee of Rs.2000/- (Rupees Two Thousand) only by cash.
