In case of failure of attendance of the candidate in the scheduled time for counselling, the Law Entrance Examination Board reserves the right to cancel his/her candidature. Total no. of seats in 1<sup>st</sup> Semester, 5 year B.A.LL.B.(Hons.) course of Tripura Govt. Law College, Agartala is 60 (sixty). Therefore, it has been resolved that in the ratio 1:3, candidates whose roll nos. are appearing in the Common Merit List up to Merit Position 180 (One hundred Eighty) are requested to appear before the Law Entrance Examination Board for counselling in person.

Seats will be filled up from the common merit list maintaining 100 point roster verified and the reservation rules of the Government for admission. Calling from 'common merit list' will be made following the order: 1<sup>st</sup>: 31 nos. Unreserved (UR) Seats which includes all categories based on their merit position; 2<sup>nd</sup>: 19 nos. ST seats; 3<sup>rd</sup>: 10 nos. SC seats; (One seat is reserved for Ex Servicemen category as per horizontal reservation; 5% seats will be reserved for PwD categories as per horizontal reservation).

At the time of counselling, a candidate whose roll no. is appearing in the Common Merit List should bring with him/her the Original testimonials/certificate:

- 1. Proof of Indian Citizenship;
- 2. H.S. (+2stage) or Equivalent Qualifying Examination Mark Sheet:

- 5. PwD Certificate issued by District Disability Rehabilitation Centre (if applicable);
- 6. Ex Serviceman Certificate issued by Rajya Sainik Board (if applicable);
- 7. One recent Passport Size Photograph.

N.B.: The admission will be done with effect from 17<sup>th</sup> September, 2025 to 20<sup>th</sup> September, 2025 from 11.30 a.m. to 3.30 p.m. in the Tripura Govt. Law College office. The candidates with admission tickets and admission forms issued by the Law Entrance Examination Board, 2025 during the counselling session will be admitted into the course with prescribed documents mentioned in the admission form and prescribed fees as per rules. It is further informed that the classes of the 1<sup>st</sup> Semester B.A.LL.B. (Hons.) for the academic session 2025-2026 will commence from 22<sup>nd</sup> September, 2025 (Monday)-From the Principal, Tripura Govt. Law College, Agartala.
