#### The above Committee shall:

- Receive and Address all complaints related to the Directorate of Higher Education and ensure their timely redressal in a fair and confidential manner.
- The Committee in discharge of its duties shall take into account the guidelines mentioned in the Sexual Harassment of Women at Workplace (Prevention, Prohibition and Redressal) Act, 2013.
- Recommend penalties and action against the respondent if the allegations are found to be true.
- Submit an annual report to the competent authority, detailing complaints received and actions taken.
- Hold meetings on a quarterly basis or as and when required.
- Communicate with the Local Complaint Committee at District Level.
- Communicate and provide assistance to the Internal Complaint Committees constituted in Universities, Colleges, and Institutions under the Higher Education Department.

- Develop and Implement Policies to prevent sexual harassment at workplace.
- Provide necessary protection and assistance to the complainant whenever required.
- Organize awareness programs, training sessions, and workshops to educate employees and students
  about gender sensitization and the prevention of sexual harassment.
- As per Section 4(3) the Internal Complaint Committee shall hold office for such period not exceeding 3(three) years from the date of issuance of this Notification.

All the employees under the Directorate of Higher Education are directed to take appropriate action to ensure that the directions and recommendations issued by the above Internal Complaints Committee (ICC) are acted upon expeditiously.

The Notification shall come into effect immediately upon issuance.
