**GUIDELINE FOR MUKHYAMANTRI KONYA
ATMONIRBHOR YOJANA (MKAY) TO PROVIDE SCOOTY
TO MERITORIOUS COLLEGE-GOING FEMALE STUDENTS**

REGULATION GOVERNING THE AWARD OF FINANCIAL ASSISTANCE

NOTIFICATION

Subject: Guideline for Mukhyamantri Konya Atmonirbhor Yojana (MKAY) to Provide Scooty to Meritorious College-going Female Students.

1.0 Short title of the Scheme: – This scheme shall be called ‘Mukhyamantri Konya Atmonirbhor Yojana (MKAY)’.

2.0 Background of the Scheme: - Government of Tripura is committed to attain higher standards of performance along with developing the institutional environment of higher education institutes conducive for sustaining that attainment.

In order to enhance the quality of higher education and to motivate and facilitate meritorious students. Government of Tripura has already started various schemes for college going students and every year a good number of students avail the benefits under those Schemes; and,

Further, to encourage and motivate the girl students to pursue higher studies and to facilitate them with necessary conveniences for pursuing the same, it is decided by the Government of Tripura to support the meritorious girl students by providing them a Scooty.

For implementing this decision, it is required to launch a scheme to provide Scooty to meritorious female students studying in General (Government) Degree Colleges. In every financial year, the benefit of this scheme shall be extended to a maximum of 140 numbers of meritorious female students.

Therefore, in view of the above, to achieve the aforesaid purposes, one scheme is adopted under the Scheme-name: ‘Mukhyamantri Konya Atmonirbhor Yojana (MKAY) Scheme’ vide Cabinet Memo No.F.8(3)-GA (CAB)/2025 dated 12/03/2025.

3.0 Objective of this Scheme: – Main objective for starting the MKAY scheme is to provide appropriate resources to motivate and facilitate meritorious girl students studying in General (Government) Degree Colleges under Directorate of Higher Education, Government of Tripura. The scheme will encourage girls to pursue higher education and become independent on their own.

Date of Effect: This scheme shall be implemented for girl students admitted to General (Government) Degree Colleges starting from the academic year 2023-24.

Source of Fund: The expenditure will be borne from the budgetary provision of the Department for implementing the Scheme.

4.0 Assistance to deliver under this Scheme: - Each eligible student will get one Scooty

complete with insurance and registration at the time of handing over to candidate.

5.0 Number of Assistance: - 100 nos. Scooty will be provided to TBSE passed out students and 40 nos. of Scooty will be provided to CBSE passed out students.

6.0 Eligibility of Student for availing the Assistance: – To become eligible for the MKAY Scheme, the applicant should have the following eligibility criteria:–

- i Female students should study in the 1st Semester of any Under-Graduate course at any General (Government) Degree Colleges under Higher Education Department, Government of Tripura.
- ii Female student should be H.S.(+2) passed out student in the immediately concluded Board Examination from any of the TBSE/CBSE-affiliated State Government-run or State Government-aided schools or CBSE affiliated schools run by Central Government.
- iii Female students having scored minimum 80% marks in H.S.(+2 stage) examination conducted by TBSE or CBSE, as applicable. This cut-off percentage of marks may be decided by the Department from year to year.
- iv Annual Family Income from all sources should not be more than Rs.8 Lakh during the immediate last financial year.
- v Applicant should possess PRTC.

7.0 Procedure for Applying for the Scheme: -

- i Candidate fulfilling the eligibility conditions is required to apply online on Beneficiary Management System (BMS) Portal after initiation of the process and publication of notice in the website of the Directorate.
- ii College where candidate is studying shall verify the online application.
- iii Department of Higher Education under Government of Tripura will verify the application as second (i.e., State) level of scrutiny.
- iv Until the scheme is functional in the BMS Portal, the process of selecting beneficiary will be conducted through 'Off-Line' Mode.

8.0 Criteria for selecting beneficiary: -

- i. Final selection of eligible candidate will be solely based on merit of the candidate on the basis of percentage of marks scored in the HS (+2 stage) Examination in the immediately concluded Board Examination.
- ii. Separate merit lists will be prepared for TBSE affiliated schools and CBSE-affiliated schools. Here, 'schools' are as defined at point-ii under Clause-6.0 above.
- iii. For converting Cumulative Grade Point Average (CGPA) to Percentage, multiplying factor will be 9.5.
- iv. For preparing each of the merit lists mentioned at point-ii above, Reservation Policy adopted by the Government of Tripura is applicable.

- v. Both merit lists will be published in the website of the Department of Higher Education [<https://highereducation.tripura.gov.in/>]; and simultaneously in websites of all Colleges under this Directorate.

9.0 Tie-breaking while selecting beneficiary: - The procedure to be adopted for breaking ties (similar percentiles) shall be as under: -

- a) Percentage of Marks in 10th Examination: In case qualifying examination percentile does not break ties, then higher percentage of marks in 10th examination will be ranked higher.
- b) Candidate of elder age will be ranked higher in case 10th examination percentage does not break ties.

10.0 Documents to be uploaded with the Application Form: - Followings are the scanned documents to be enclosed:

- i) Class 10 Admit Card and Mark sheet of candidate as proof of age.
- ii) 12th mark sheet of candidate.
- iii) Permanent Resident of Tripura Certificate (PRTC) issued by the SDM.
- iv) Annual Family Income Certificate issued by the SDM/DCM.
- v) Study/ Bona fide Certificate issued by the college.
- vi) Family Ration Card.
- vii) Aadhar Card of candidate.
- viii) Passport size color photo of candidate.
- ix) Front-page of Bank Account Passbook of the candidate, having details.

11.0 Terms and Conditions: -

- a) There should be no gap period between the year of passing the qualifying examination and the session of admission in Under Graduate course.
- b) Applications will be invited once in a year through BMS Portal.
- c) Only verified online applications will be considered for the award of this assistance.
- d) Candidate once received scooty under this Scheme shall not sell the Scooty. In this regard, candidate has to submit one Undertaking to the Department of Higher Education before receiving the scooty.
- e) The scooty must be registered in the name of the candidate.
- f) Candidate having any grievance can write to the Directorate of Higher Education, Government of Tripura through their respective colleges.
- g) Scheme will be implemented and monitored by the Department of Higher Education, Government of Tripura.
