1. Terms & Conditions:

- A. The quotations if received after this deadline or if found to be without sealed cover shall not be entertained under any circumstances whatsoever. - **B.** Quotations must be in the enclosed prescribed Proforma on the letter head of the firm duly signed by the Proprietor/ Partner/ Director or, their authorized representative. - C. Qualification criteria: Only registered firms located in Tripura fulfilling the following conditions may apply:
 - a) The Audit Firm shall be in existence for a minimum period of 3(three) years. Copy of the Registration Certificate issued by ICAI shall be attached.
 - b) The applicant should not have been black listed/debarred/ disqualified by any Regulatory/ Statutory Body or Government entity or any International/National agency for corrupt or fraudulent practices.
 - c) The Firm should have an Office/Branch Office in Agartala.
 - d) Firm shall be registered with GST and GSTIN Certificate shall be attached.
 - e) The firm has to provide the TDS Certificate submitted by the firm along with the Quotation
 - f) A copy of the similar prior audit done by the firm shall also be attached with the quotation as Experience.

D. SCOPE OF WORKS
