• The distribution of seats is in accordance with the Reservation Policy adopted by the Tripura Government. 03 (three) seats are reserved for 'Person with Disability (PwD)' candidates in the overall 50 seats.

2] Beside this, North Eastern Regional Institute of Science and Technology (NERIST) Arunachal Pradesh, this year, offers 'earmarked seats' (as per the Roster of the NERIST) to Tripura, to be allocated through the 1<sup>st</sup> (and 2<sup>nd</sup>, if required) round of CSAB 2024 counseling; and seat distribution for NERIST will be available in the Brochure of the CSAB NEUT 2024. To avail seats offering by the NERIST, student must have to produce and upload PRTC along with other documents as specified by the CSAB NEUT 2024 authority. In case of seats offered by the NERIST for PwD (or Physically challenged) candidates, candidates must have **40% to 75% locomotor disability** only to become eligible for these seats along with fulfilling other criteria.


• Candidates should directly apply online with Central Seat Allocation Board (CSAB NEUT)-2024 ([www.csab.nic.in](http://www.csab.nic.in)) for admissions against these seats from **June 17<sup>th</sup> (starts from 10:00 AM) to June 24<sup>th</sup> (5:00 PM Close), 2024**. The Directorate of Higher Education, Agartala, Tripura, will act as 'Reporting-cum-Help-Centre' for CSAB NEUT-2024 [OSD (Technical Education), Higher Education, Tripura, Room No.03, Shiksha Bhawan, Phone: 0381-2314402].

• **During online registration**, candidate will be required to **upload/verify the scanned copy** of the following original documents in **pdf OR jpg format** against their claims, viz, i) Photo ID Proof (as per GOI), ii) Admit Card of JEE(Main)-2024, iii) Class X Board Certificate (as proof of date of birth certificate), iv) Class XII Certificate (aggregate percentage of class 12<sup>th</sup> or equivalent marks), v) PRC/Domicile certificate, vi) Category certificate (issued by competent authority), vii) PwD certificate (if applicable) (certificate should be issued from a duly constituted Medical Board and certificate should stand valid up to 31.12.2024. Certificate not issued by a medical board &/or getting expired before 31.12.2024 shall not be accepted.), viii) Proof of place of examination center in case of final qualifying examination is from the National Institute of Open Schooling (NIOS), ix) Medical Certificate (Format is provided in the CSAB NEUT 2024 Brochure), x) Declaration from Candidate and Parent (Format is provided in the CSAB NEUT 2024 Brochure at **Pg.128**), xi) One passport size photograph identical to the one pasted on the JEE (Main) 2024 application form, etc. on [www.csab.nic.in](http://www.csab.nic.in).
