**NOTIFICATION**

In pursuance of the letter of the Director of Higher Education, Govt. of Tripura vide No.F.2(309-4) DHE/UDCA/2008/968 dated 20/03/2021 the Second Amendment to the Law Entrance Examination Regulations has been approved by the Government and is hereby notified as follows:-

**Tripura Law Entrance Examination Regulations (Second Amendment), 2021**

**1. Short Title and Commencement :**

This Regulation may be called the Second Amendment of Law Entrance Examination Regulations, 2021.

It shall come into force from the date of issue of the Notification.

**2. Amendment of Regulation -5:**

In the Principal Regulation i.e. Law Entrance Examination Regulation-2015, the Regulation 5, Sub-Clause (i) shall be substituted as follows:-

**Syllabus and medium of Law Entrance Examination:**

Duration of Examination: 2 hours

Type of Questions: MCQ (Multiple type questions with four options)

Total Number of Questions: 150 Nos.

Marks Allotted for Each Question: 1 (one)

Negative Marking: 0.25 for each wrong answer

Medium of Question Booklet language: English

**Syllabus:**

English (50 questions),

General knowledge and current affairs (75 questions),

Legal aptitude (25 questions).

**English**

English Vocabulary: Antonyms, Synonyms.

English Proficiency: Idioms and Phrases, One word substitution, Rearrangement of Sentence in Paragraph, Rearrangement of words in sentence, fill in the blanks and cloze tests.

English Usage Errors: Common Errors, Spotting errors, inappropriate usage of words and spelling mistakes (English usage) and use of correct word.

English Comprehension: Paragraph will be given. Questions will be asked from that paragraph, Understand the Para and answer the questions accordingly.

**General Knowledge and Current Affairs:**

History: Modern history of India and Indian national movement

Indian Polity and Governance: General information regarding Indian polity and governance, Constitution of India, Panchayat Raj etc.

Indian Geography: Physical and Economic geography of India

Indian Economics: Five year plans, general economic terms, economic development in India, Poverty

General Knowledge: Static general knowledge including general knowledge of Tripura

Current Affairs: Knowledge of major events that have occurred in India and worldwide over the past few years in the area of economics, science, technology, sports, persons, places etc.

**Legal aptitude:**

This section will judge your interest towards study of law, research aptitude and problem solving ability.



These questions will be related to legal propositions and set of facts satisfying the propositions. Such propositions may or may not be true, you have to assume them and answer the questions accordingly.

Some major topics are International Law, Criminal Law, Indian Constitution, Legal Terms, Legal Maxims, Family Law, Contracts and Torts.


**3. Amendment of Regulation 6:**

In the Principal Regulation i.e. Law Entrance Examination Regulation-2015, Regulation 6 is repealed.

**4. Amendment of Regulation -18:**

In the Principal Regulation i.e. Law Entrance Examination Regulation-2015, in the Clause A, Sub-Clause (X) of the Regulation 18 the following shall be included:-

*However, only those candidates who remain present during the first round of counseling but not allotted any seat shall be eligible for the subsequent counseling sessions.*
