NOTIFICATION

In exercise of the power conferred by proviso to article 309 of the Constitution and in supersession of the existing recruitment rules for the post mentioned herein, the Governor hereby makes the following rules regulating the method of recruitment to the post of Sorter under Education (Higher) Department namely :-

1. **Short Title and commencement.-**

- (a) These rules may be called the Sorter under Education (Higher) Department Recruitment Rules, 2009.
- (b) They shall come into force on the date of their publication in the Official Gazette.

2. The name of the post(s) shall be specified in Column-1.

3. Number, classification and scale of pay.

The number of the said post, its classification and the scale of pay attached thereto shall be as specified in Columns 2 to 4 of the Schedule annexed hereto.

4. Method of recruitment, age limit, qualification etc.

The method of recruitment to the said post, age limit, qualifications and other matters relating to the said post shall be as specified in columns 5 to 13 of the said schedule.

5. Disqualification :- No person,

- (a) Who has entered into or contracted a marriage with a person having spouse living ; or
- (b) Who, having a spouse living has entered into or contracted a marriage with any person shall be eligible for appointment to the said post :-

Provided that the State Government may, if satisfied that such marriage is permissible under the personal law applicable to such person and the other party to the marriage and that there are other grounds for so doing, exempt any person from the operation of this rules.

6. Power to relax :- Where the State Government is of the opinion that it is necessary or expedient so to do, it may, be order, for reasons to be recorded in the writing and in consultation with the Tripura Public Service commission, relax any of the provisions of these rules with respect to any class or category of persons.

7. Saving :- Nothing in these rules shall effect reservations, relaxation of age limit and other concessions required to be provided for the Schedule castes, the Schedule Tribes, Ex-Servicemen and other special categories of persons in accordance with the orders issued by the State Government from time to time in this regard.

AMENDMENT OF RECRUITMENT RULES FOR THE POST SORTER UNDER THE EDUCATION (HIGHER) DEPARTMENT, GOVT. OF TRIPURA.

| 1. | Name of the post | :- | Sorter, Education (Higher) Department. |
| 2. | Number of post(s) | :- | 125 (one hundred twenty five) plus additional post(s) as and when created. |
| 3. | Classification | :- | GROUP- C (Non-Gazetted). |
| 4. | Scale of pay | :- | Pay Band-2 Rs. 5310-24000/- with Grade Pay Rs. 1600/- (subject to revision by State Government from time to time). |
| 5. | Method of recruitment whether by direct recruitment or by promotion or by transfer and percentage of the vacancies to be filled by various methods. | :- | 50% by direct recruitment & 50% by promotion failing which by direct recruitment. |

6. Age limit for direct recruitment :- 18 to 37 years. Upper age limit is relaxable by 5 years in case of ST/SC/PH candidates and Govt. servants.
7. Educational and other qualifications required for direct recruitment. :- Essential :-
i) At least Matric standard.

Desirable :- i) Experience of work in Libraries.
8. Whether age and educational qualifications prescribed for the direct recruitment will apply in case of promotion. :- Age-No, Qualification-No.
9. Whether selection post or non-selection post. :- Non-Selection.
10. Period of probation, if any : 2(two) years.
11. In case of recruitment by promotion/ deputation/transfer, grade, from which promotion/deputation/transfer is to be made. :- Promotion :- From Group-D employees possessing the qualification of Class-VIII passed with 5 years service in the grade.
12. If a D.P.C exists, what is the composition. :- "Group-C, D.P.C."
13. Circumstance in which T.P.S.C. is to be consulted in making recruitment. :- Not applicable.
