#### ADMISSION NOTIFICATION AND GUIDELINES

Maharaja Bir Bikram University, Agartala invites online applications available in the MBB University Website (www.mbbuniversity.ac.in) for admission to 1 (one) year Diploma in Goods and Services Tax (GST), Retail and Sales Management, Insurance Risk Management and Spanish Language (in Selffinance mode) evening programme for the academic session 2020-2021. Online filling up of Application Forms and submission of the filled up Forms is scheduled from August 16, 2020 (10.00 AM) to August 31, 2020 (04.00 PM). The candidates are required to fill up the online form and upload the necessary documents and photograph.

# A. ELIGIBILITY CRITERIA (ESSENTIAL):

Diploma in Goods and Services Tax (GST), Retail and Sales Management, Insurance Risk Management and Spanish Language (in Self-finance mode) evening programme:

Any student passing H.S (+2) examination or its equivalent examinations with at least four (4) subjects including English from any recognized Board/Council shall be eligible for admission to the Diploma programmes subject to availability of seats.

Candidates with higher qulificatuions are also eligible to apply. However, merit list will be prepared strictly on the basis of the aggregate marks secured by the candidtes at H.S (+2) examination.

Mere possession of 'Eligibility Criteria' does not entitle right of anyone to get admission to any programme under Maharaja Bir Bikram University. Regarding selection of Eligible Candidates for admission, decision of the Admission Committee shall be final.

# C. Guidelines for Preparation of Merit List and Selection Procedure

# CALCULATION OF SCORES OF EACH CANDIDATE For Admission to Diploma Programme

The merit list shall be prepared according to the merit position to be determined after calculating the marks / Grade points /score in the following manner:

The percentage of marks / grade point / CGPA obtained in the Higher Secondary (H.S.+2) Examinations of the candidates who have successfully completed Higher Secondary Examinations and fulfill eligibility criteria as mentioned in point 'A' shall be considered for admission.

- **D.** If the secured marks of two or more Candidates are equal i.e. if there is a tie, then the following steps shall be followed, one after another, to break the ties.
  - a. Marks obtained by the Candidate in the Higher Secondary Examination in the concerned subject (subject in which candidate applied for admission) shall be taken into account and the candidate who has secured more marks shall be given preference.
  - b. If the Marks in the concerned subject (subject in which candidate applied for admission) in the Higher Secondary Examination is also same, then the Marks obtained in the Matriculation Examination shall be taken into account and the candidate who has secured more marks in aggregate shall be given preference.
  - c. If the Marks in the Matriculation Examination are also same, then the Date of Birth of the Candidates shall be taken into account and the senior candidate shall be given preference.
  - d. If the Date of Birth is also same, then the tie will be broken by listing the name of the Candidates Alphabetically.

[If step (a) fails, step (b) would be followed; if steps (a) and (b) both fails, step (c) would be followed; if steps (a), (b) & (c) fail, step (d) would be followed.]

#### E. COUNSELING AND PROVISIONAL ADMISSION:

- The University shall conduct Counseling for provisional admission of Students on the basis of the merit list prepared following the reservation policy of Government of Tripura on a notified Date and Time. In the Counseling, the University shall verify all original documents and verify the documents along with information already provided by the candidate at the time of submission of Online Forms.
- Students are required to submit self-attested photocopies of academic testimonials as well as all other documents including photo as per instruction of the University.
- 3. Student will have to take provisional admission on the notified Date and Time on the day of Counseling by depositing the requisite admission fee as determined by the University, failing which their Candidature will automatically be treated as cancelled and the vacant seat shall be filled up from the waiting list in the order of merit. A candidate must be present in person at the place of admission notified by the University.

#### F. RESERVATION:

As per existing reservation policy of the Government of Tripura, the available reserved seats shall be distributed among the reserved category candidates.

- Candidates are advised to check the eligibility criteria thoroughly and must fully satisfy
  themselves about their eligibility as prescribed before applying for any programme. Hence,
  applicants will be responsible themselves if they opt for a programme for which they are not
  eligible.
- Candidates are required to fill carefully all details in the prescribed online application form without making any spelling mistakes.
- 3. No forms will be accepted after August 31, 2020 (Time: 04.00 PM).
- 4. Applicants are required to upload the following documents
- One recent Passport Size Photograph.
- Signature of the Applicant
- Matriculation Examinations Admit Card for age verification.
- Matriculation Marksheet (both sides)
- Higher Secondary Marksheet (both sides)
- Graduation Final Mark sheet (both sides)

- Mater Degree Final Marksheet (both sides)
- Ph.D. Certificate or any other qualification Certificate
- SC/ST Certificate issued by the competent authority.
- PWD (Person with Disability) Certificate issued by the competent authority.

If any applicant has multiple marksheets for any year, he/she is required to upload all Marksheets (both sides) making one PDF file, i.e. First marksheet, then its back side, followed by the Second marksheet with its back side. Follow the same process if one has more marksheets for the same semester.
- Please note that:
- Only one Application Form should be submitted for one subject.
- Submission of Multiple Application Forms for one subject is strictly prohibited.
- Separate Application Form should be submitted for each subject.
- 7. Maharaja Bir Bikram University reserves all rights to change this notification at any point of time.
- 8. For foreign nationals (if any) their application will be considered separately by Admission Committee.
- 9. In all issues relating to the Admission Process for the Academic Session 2020-2021, decision of the Maharaja Bir Bikram University shall be final.
