# Educational Notification for 2<sup>nd</sup> Round Counselling, SPOT Counselling and Diploma Engineering Admission through DEEET-2021

This is for information of all concerned that, issue of seat allotment letter after 2<sup>nd</sup> round online counseling, Spot Counselling and admission into respective Polytechnic Institutes will be as per the schedule given below:

## **Important Instructions:**

- 1. The candidates, who have surrendered their 1<sup>st</sup> round allotted seats, will be allotted seat in 2<sup>nd</sup> round. Online counselling will be done and separate 'Seat Allotment Letter' will be issued based on choice(s) fed by the candidates in the portal for the first time. Thereafter, candidates have to download their 2<sup>nd</sup> round 'Seat Allotment Letter' afresh from DEEET Portal available in the website: https://highereducation.tripura.gov.in.
- The candidates, who are unwilling to take admission in that allotted seat, have to surrender allotted seat in the DEEET portal on or before 2<sup>nd</sup> October 2021 upto 11:59 pm to become eligible for Spot Counselling.
- 3. If a candidate has not taken admission in any Polytechnic/Institute and also not surrendered that seat in the DEEET portal within scheduled date in that case such student will not be eligible to take admission through any further round of admission process.
- 4. If any candidate surrenders their 2<sup>nd</sup> round allotted seat, such candidates will be eligible to appear the Spot Counselling.
- 5. The candidates, who have DEEET-2021 merit position and were not allotted seats (due to insufficient choice filling) in 1<sup>st</sup> & 2<sup>nd</sup> round counselling process, will also be eligible to appear the Spot Counselling.

- 6. For the Spot Counselling, candidates have to report to the CSC Office at the premises of Birchandra State Central Library, Agartala. Counselling will start at 12 noon and seats will be allotted as per the merit position of <u>physically present candidates upto 12 noon</u>. Seats will be allotted as per availability and maintaining common merit list of DEEET-2021.
- 7. Candidate must be physically present in the Spot Counselling process before 12 noon on 9<sup>th</sup> October 2021 with one guardian/parent only, to avoid mass gathering. Candidates and guardians/parents are advised to strictly adhere to COVID-19 guidelines.
- 8. A 'Seat Allotment Letter' will be issued to candidates manually on the spot.
- 9. At the time of admission in the respective institutions, candidates must bring 'Seat Allotment Letter', two recent photograph, relevantoriginal documents along with two photo copies of the same like Madbyamik Marksheet, PRTC, Caste Certificate, Proof of Ex-serviceman (ESM) and PwD Certificate (if applicable), Madhyamik Admit Card and Requisite Fees of that respective Institute. The amount of requisite fees and submission mode (Cash/Card/Net banking/Challan) may be confirmed before hand with the concerned institutions. After successful verification of these documents and payment of requisite fees only, the students will be admitted in that institute.
- 10. Candidates those are ward of Ex-serviceman (ESM) have to verify their 'Seat Allotment Letter' from Rajya Sainik Board, Gurkhabasti and have to bring that verified 'Seat Allotment Letter' to respective institute for admission. Without proper verification by 'Raiya Sainik Board' no candidate will be entitled under Ex-Serviceman (ESM) quota.
- 11. There will be Internal Sliding/branch change of interested candidates on 7<sup>th</sup> October 2021 within respective institute where candidates have taken admission.
- 12. All other terms and conditions will remain same as declared by CSC in the first notification.
