Sir/ Madam,

In inviting a reference cited above and decision of the meeting held on January 14, 2021 this is to inform you that the following insertions and modifications in Regulation No. 22 of the First Regulations, 2018 of the MBB University were proposed considering the academic interest of the student with the approval of the Vice-Chancellor:

- i) Regulation 22 "Restrictions on Combination of Subjects" in para 4 in page no 08 of First Regulations 2018 of MBB University be modified with "If a candidate desires to take Economics(Honours) in Undergraduate Programme, he/she shall preferably take Mathematics as Generic Elective (GE) subject or he/she have to take one subject as Generic Elective(GE) as mentioned in Annexure G, provided that subject taken as Honours cannot be taken as a generic Elective (GE) subject."
- Regulation 22 "Restrictions on Combination of Subjects" in para 8 "vii Economics (Honours)
 Mathematics" in page no 09 of First Regulations 2018 of MBB University be omitted from
 the Regulations of the MBB University.
- iii) Regulation 22 "Restrictions on Combination of Subjects" para 9 in page no 09 of First Regulations 2018 of MBB University be incorporated with "If a candidate desires to take Economics (Honours) in Undergraduate Programme, he/she scored at least 50 marks or Equivalent Grade in Mathematics in the Madhyamik/ Secondary level."

It is also decided that the feeder schools be asked to encourage and allow students in Higher Secondary level to opt the subject combinations of Economics and Mathematics for increasing the quality of education and better understanding of the subject.

This is issued with the approval of the Vice-Chancellor.
