NOTIFICATION

Sub: Quantum of minimum and maximum pension/family pension of teachers in the State Universities, General Degree Colleges and Institute of Advanced Studies in Education (IASE), College of Teacher Education (CTE), Government Music College and Government Law College and the administrative officers under the State Universities under the University Grants Commission (UGC) as per the UGC Pay Regulation, 2018 on the recommendation of the 7th Central Pay Commission (CPC).

The Government of Tripura has implemented the revised UGC Pay Scales recommended by the 7th CPC for the teachers of Colleges and Universities and administrative officers of State University in the State vide Government Notifications No.F.1(499)-DHE/Estt.(G)/2019(L-I)/727 and F.1(499)-DHE/Estt.(G)/2019 (L-I)/ 728 dated 25.06.2019 respectively.

Now, the quantum of minimum and maximum of pension/ family pension as per UGC pay regulation, 2018 following the recommendation of the 7th CPC need to be notified.

The minimum and maximum amount of pension/family pension for the Faculty members falling under UGC pay scale and minimum and maximum amount of pension/family pension for the administrative officers of State University will be as follows:

The minimum & maximum pension ceiling would be:

Minimum amount of pension/family pension for faculties falling under UGC pay scale may be fixed at Rs.28,850/- per month [50% of level 10 of UGC pay matrix @ Rs.57,700/- for College teachers].

The minimum amount of pension/family pension for administrative officer of MBB University falling under UGC pay scale may be fixed at Rs.28,050/- per month [50% of level 10 of UGC pay matrix @ Rs.56,100/- for Registrars/ Finance Officers/ Controller of Examinations].

Maximum amount of pension for faculties falling under UGC pay scale and administrative officer of MBB University may be fixed at Rs.1,12,050/- per month [50% of level 15 of UGC pay matrix @ Rs.2,24,100/-]

Maximum amount of family pension may be fixed at Rs.56,025/- per month [50% of maximum limit of pension].
